Essential Qualifications: Post Graduate in Business Administration with good academic records.

Desirable Qualifications: Preference will be given to the candidate having experience in academic research.

Fellowship (per month): Rs 7500/- per month for a period of 6-8 months (as per the requirement) from the date of appointment.

Other Benefits: Facility of casual leave, medical leave, etc, may be applicable as per the rules of project staff.


Tenure of Appointment: For the period of 6-8 months (as per the requirement) only.
